

Movin' Out **Down Payment Assistance Scenarios**

*Movin' Out housing counselors may be able to help eligible households apply for down payment assistance from various sources. The amounts below represent **maximums**; the amount available to an individual household will vary according to the gap that needs to be filled, availability of funds, and other factors.
